- d. Approval of the Agenda
- 2. PUBLIC DISCUSSION: The public is welcomed and encouraged to address the Board at this time on matters not on the Agenda. Please be advised that pursuant to Government Code Section 54954.2, the Board is not permitted to take action on any matter not on the Agenda unless it determines that an emergency exists or the need to take action arose after the posting of the Agenda. This period will be limited to thirty minutes and individual speakers will be limited to five minutes.

### 3. OLD BUSINESS:

- a. City and Planning Unit Outreach Efforts Update: Committee members Peterson and Abercrombie will report on their progress on working toward a shared vision with the City of Healdsburg at the Healdsburg City Council level.
  Presentation of Fred Peterson's letter to Healdsburg City Manager Jeff Kay.
- a. Strategic Planning Update: Strategic Planning Ad Hoc Committee members Abercrombie and Newman will announce any updates on the strategic plan.
- b. Fire Station Updates: This time is set aside for comment/discussion on matters relating to the acquisition of land, architectural designs, construction plans, building and landscaping maintenance, funding sources, and site suitability of current and future firehouses.
- c. FEMA Grant Funding: Discussion regarding the need for Cloverdale FEMA grant funding.
- d. Fire Sales Tax Measure:
  - i. REQUESTED ACTION: That the Board of Directors consider approving a Resolution taking an official position supporting "THE IMPROVED AND ENHANCED LOCAL FIRE PROTECTION, PARAMEDIC SERVICES AND DISASTER RESPONSE INITIATIVE", Measure [X] on the March 5, 2024 Sonoma County ballot.
  - ii. DISCUSSION: The District Board of Directors will consider and decide whether to officially support Measure [X]. A Resolution expressing such support is attached for the Board of Directors' consideration. The Board of Directors is permitted to consider, and take action to express, the opinion of the District's Board of Directors supporting or opposing a ballot measure that impacts the District, as long as it does so at an open public meeting. - f. Assistant Fire Chief: Continue discussion of Assistant Fire Chief position.

- a. MAC Representative: Discussion and nomination of District representative to MAC (Municipal Advisory Committee).
- b. Proposed Sick Leave, Holiday, and Step Raises:
  - i. Increase sick leave for part-time and temporary employees for compliance with SB 616.
  - ii. Increase sick leave of full-time fuel crew members from 3.96 to 4 hours per pay period.

- iii. Increase holiday pay of full-time fuel crew members from 8 to 10 hours.
- iv. Step raises (steps 1 5) of 2.5% for full-time fuel crew members.

- 6. FINANCIAL REPORT: Review of current and year-end financial reports.
